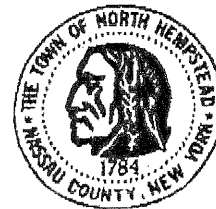

Re: Request Authorizing the Increase and Improvements of Facilities  
for Combined Plant Upgrade.

Dear Commissioners:

As per the Supervisor's request, please provide final detailed estimates of the total cost of improvements in the amount of **\$68 million** prepared by a competent engineer duly licenced by the State of New York. Estimates prepared by certified public accountants, consultants, and/or financial firms will not be accepted.

In addition, please advise as to the reasons why the District no longer wishes to extend the District, and/or enter into an inter-municipal agreement that anticipates: (1) treatment of the Village's effluent; (2) acquisition of the Village's collection system; (3) combination of the District and Village plants; *and* (4) extension of the district boundaries to include those areas of the Village not currently included therein. If this is not accurate, please advise.


Finally, please advise as to how the District plans to proceed with the draft inter-municipal agreement submitted to the District by Stephen Limmer, Esq. on July 15, 2008. To date, neither the Town nor the Village have received comments from District counsel.
